Premium Payment**

All private employers will have an installment payment due on 06/23/2025.

How do you make a payment?

Paying for your employer policy online is the best way to ensure we receive your installments on time. You'll need an OHID account to pay online. Refer to [OHID for employers](#) to get started.

Once you have an OHID account, log in to our website and click the "Make a payment" button.

You can pay online with:

- A credit card (MasterCard®, VISA® or American Express®)

A checking or savings account withdrawal

Private Employer 2% Early Payment Discount

Private employers who pay your entire estimated annual premium for policy year 2025 by July 1, 2025, will receive a 2-percent discount. You cannot deduct the discount up front.

You can pay in multiple ways, including:

- Online by credit card (VISA®, MasterCard®, American Express®).
- ACH (withdrawal from checking/savings account).
- Phone through the BWC Customer Contact Center at 1-800-644-6292.

Mail a check or money order payable to Ohio Bureau of Workers' Compensation, P.O. Box 89492, Cleveland, OH 44101-6492

Important Note: Payment must be posted to BWC's system by July 1st to qualify for the rebate. Payments can take 2-3 business days to post to BWC's system.
